Keeping Kids Healthy While in Foster Care

- o Children in out-of-home placement must receive
 - A CHDP Health Assessment or equivalent Exam per the CHDP Foster Care schedule (see attached CHDP periodicity schedule)
 - Within 30 days of <u>initial</u> out-of-home placement (*not at every change of placement*)

- <u>Annually</u> (Children under age 2 need more frequent well-child checks)
- It is recommended that a child receive an exam upon returning to out-of-home placement after failed reunification with parents, for recovered run away children, and/or at the discretion of the child's medical provider.

• The Medical and Dental Treatment Form

- Is used to document <u>significant</u> medical and dental information into the Health & Education Passport document
- Should be taken to the following appointments
 - Initial and annual CHDP physical exam
 - Dental exams
 - Specialty appointments
 - **Emergency** room or urgent care visits, and
 - Follow-up visits for problems found at time of physical or dental exams.
- Please note that a copy of exam progress note or PM-160 form may be faxed in lieu of The Medical and Dental Treatment Form.
- Make sure the completed form is *faxed* to Foster Care Nurses as soon as possible
- <u>Dental exams are recommended **twice** a year</u> and are a covered benefit under Denti-Cal Insurance
- All children one year of age and above require an annual dental exam.
