## New Year Reflection:

Redwood trees are the tallest living things on earth, with the tallest tree in Muir Woods standing over 250 feet tall. The trees are so wide that it would take 30-40 people holding hands to encircle the entire tree. Amazingly, most of the Redwoods in Muir Woods are anywhere from 500 to 800 years old. So just how do these trees grow so tall and survive hundreds of years in the forest? Surprisingly, the roots of the redwoods are very shallow- only 6 to 12 feet deep. And yet, those roots support a tree that approaches the height equivalent to a football field! How is this possible? The roots of the redwood trees grow outward over 60 feet instead of deep underground. The roots extend and interlock with the roots of other redwood trees nearby and they form a strong bond. This vast underground root system ensures a firm foundation and source of strength for all the redwoods. The roots of older redwood trees hold on to the roots of new redwood trees beginning to grow. The strength is shared and propels the younger trees to soaring heights. In essence, they survive because they support each other. It is this vast interconnected root system that protects the trees during extreme conditions including windstorms, earthquakes, and flooding. The roots of the redwoods intertwine underground and together can withstand these forces. The trees could not survive on their own; this is why one never sees a redwood standing alone. Ever.

### Fostering Connections

Keeping kids connected to their families during the holidays can be a challenge with all of the activities we have going on in our lives, but it is critical for the children. The holidays can intensify the grief and loss children feel from being separated from their families. By working to find creative ways to help them stay connected, we can lessen some of these feelings and help them enjoy a beautiful season. Some things you can do to help your child are:

- Ask them about the holiday traditions they shared with their birth families and try to incorporate some of them into yours. The children in your home may miss some of the activities they experienced with their family or in a previous placement.
- If possible, ask your child's family members about their holiday customs and traditions. Ask about their beliefs and observances. Although you may feel stretched thin at the holidays, try to coordinate schedules with the birth family to share an activity together. This gives children a chance to experience what is familiar to them while also experiencing new traditions. By celebrating together in small ways your child will feel reassured and enjoy the holidays more.
- This is a good time for the youth in your home to make small gifts and send cards to their birth families or old neighbors and friends. Help them to make cookies or decorations, or put together a small stocking for a loved one. These can be delivered at visits.
- Record a video of your foster child performing a little holiday greeting for their family. Dress them up in holiday clothing and have them sing carols or read "The Night Before Christmas" into the recording along with a personal message to their family. This will warm everyone's hearts!

And finally, remember this is also a time when many children experience conflicted feelings about their birth families and worry about them. Reassure them and let them know it is okay to think about and miss their families. This is a great time to remind foster children that there is enough room in their hearts to love and care for everyone in their lives.

### **AGENCY UPDATES:**

Continuum of Care Reform

Former foster children have told us and research has long shown that children living in family settings have better outcomes than children placed in long-term congregate care. AB 403 Continuum of Care Reform (CCR) includes components to reduce placements in congregate care settings, transitioning children and youth into family settings while transforming group homes into a new category of congregate care facility defined as Short-Term Residential Treatment Centers (STRTCs). These STRTCs will be utilized for time limited placements with specific treatment goals. In order to help our children and youth make the transition from residential settings into family homes we need more quality caregivers who are willing and able to meet their needs. To assist with this transition, CFS is evaluating additional training and supports we can provide to enhance our caregivers' capacity and prepare them for helping children make the shift from institutional care to family life. We will continue to provide more information as we refine our implementation plans. Stay tuned for exciting new training opportunities coming your way. This is also a great time to consider expanding your niche to accommodate older children who will need a family to support them as they transition out of congregate care. Please Note: As part of CCR, we are seeking to increase the number of Emergency Shelter Foster Homes (ESFHs) serving children 0-18 for up to 30 day placements. Eligible caregivers are licensed for a minimum of two children aged 0-18. ESFHs receive an additional monthly retainer for each ESFH bed and work closely with the agency to ensure a smooth transition for the children either home, to a relative or to a stable placement. ### Resource Family Approval Resource Family Approval (RFA) is the new foster and relative

Resource Family Approval (RFA) is the new foster and relative caregiver approval process effective in Ventura County on March 1, 2016. RFA consolidates elements of the current licensing, relative approval, adoption, and guardianship processes. This means there will now be one streamlined approval process for all caregivers, thereby eliminating the need for a family to obtain additional fingerprints, approvals, and home studies if the case plan changes for a child in their care. If a caregiver is currently licensed, they will not be required to be reassessed as an RFA caregiver and will be eventually grandfathered into the new system. However, if a current licensed foster family wants to adopt, they may be required to go through the adoption home study process or the RFA process. For more information, join us at one of our RFA update trainings in January and February. Dates and locations will be mailed out to all caregivers.

## Introducing Safety Organized Practice iFoster Updates!

The term 'Safety Organized Practice" was first used to describe an approach to day-to-day child welfare casework. The practice is designed to help all key stakeholders involved with a child – parents, extended family, caregivers, child welfare workers, supervisors, managers, lawyers, therapists, CASAs, judges, and even the child him/herself - keep a clear focus on assessing and enhancing child safety at all points in the case process. The overarching goals for SOP:

- Development of Good Working Relationships: Using a spirit of curiosity, practices of family engagement, and a shared language for important child welfare concepts to help create good working relationships among all stakeholders involved with a family.
- Use of Critical Thinking Decision Support Tools: Helping all stakeholders use the best of their experience and the best state-of -the-art child welfare research to jointly assess family situations and arrive at clear statements of both the harm and danger to the children, and the goals for a child welfare intervention.
- Creation of Detailed Plans for Enhancing Safety of Children: Creating jointly developed, understandable, achievable, and behaviorally based plans that include all stakeholders and clearly show how the protection of children will be enhanced on an ongoing basis.
- Child-Centered Engagement through Solution Focused Questions: "What's working well? What are we concerned about? What needs to happen next?" These are questions that will guide many of our interactions with children, families and caregivers as we seek to ensure that the child's voice and good working relationships are central to our child welfare practice.

In the coming year, caregivers will be given training opportunities to participate and learn more about Safety Organized Practice. Are you a member of the www.ifoster.org online resource portal community? If not, please take a few minutes to register at www. ifoster.org. By registering, you are signing up for local and national retail discounts and deals, local resources to help you meet your child's needs, and some goodies to support you and the youth(s) in your care. Remember, foster, adoptive, relative caregivers, and transition-aged youth are eligible for their own accounts! You can also call iFoster at 1-855-936-7837 and they can sign you up over the phone and help you navigate the resource opportunities. Are there resources missing from the portal? Contact iFoster! They are interested in identifying new resources to support our caregivers.

iFoster has added two components to the iFoster portal that can have added benefits for the child in your care. When you log in, you are taken to your home page where you will see an option for "My Child's Successes." By clicking on this, you can share successes and milestones your child has achieved. This will also enter your child into a drawing for some cool prizes donated by iFoster's corporate partners. You will be asked to provide supportive documentation of the achievement (report card, certificate, letter, etc) that you will upload into the secure portal. This becomes a cloud-based "backpack" of your child's success.

The 2nd addition is the Digital Locker for transition-aged youth. This locker, again with online banking level security, is a place where youth can store digital copies of their report cards, Medi-Cal card, photos, memories, school assignments, letters from the court or social workers, and many other important documents that often get lost along the way. Youth can sign up for their own iFoster account and access the portal. Upload documents by scanning, taking a photo with a smart phone or tablet, or directly from a computer. The locker supports a range of file types including PDFs, JPGS, and more!

## Learning from the Research

Elizabeth Kolbert presents an interesting summary of new research in a recent article in the New Yorker entitled "The Terrible Teens: What's wrong with them?" which examines adolescent brain development. Kolbert presents information from neurologist Frances Jenson that demonstrates that "teens are not quite firing on all cylinders when it comes to the frontal lobes..." She explains that the frontal lobes are the part of the brain that help with planning, self-awareness and judgment. When optimally functioning, the frontal lobes act as the "brakes" for impulses coming from other parts of the brain. During the teen years, the brain is still building connections between different areas of the brain. The links to the frontal lobes are one of the last regions to be connected and the complete process can last until the twenties or even thirties. Given this, parents need to act as their teens frontal lobes and help them with things like planning and judgment, as well as understanding that their brains are not fully "online" yet.

Another researcher that Kolbert brings into her article is Laurence Steinberg. His work has found that the "pleasure center" of the brain (known as the nuclear accumbens) hits maximum development during adolescence and then begins to shrink into adulthood. Note: teens are wired to seek enjoyment and excitement. This means that despite knowing the risks, the potential rewards of risky behavior seem greater to adolescents. These findings may explain why teens can answer why what they did was wrong but still did it anyway! Their brains are wired for excitement and enjoyment but still lack the cognitive capacity to consistently control their impulses and make safer choices. ## Foster Care Snapshot: The Critical Need Continues...
