School's Out For the Summer!

Summertime is upon us! While children often count the days down to summer vacation, caregivers are scrambling to find childcare, day camps, and other activities to keep children engaged while they are out of school. We hope this issue of **The Foster Network** will give you some ideas on how to keep your kiddos busy this summer!



Extracurricular, Enrichment, and Social Activities

Court dependent children are entitled to participate in age-appropriate extracurricular, enrichment and social activities. Caregivers (relative and foster parents) have the discretion to authorize or deny such activities by utilizing the "reasonable and prudent parent standard" without prior approval from the child's social worker, licensing department, or the juvenile court. By utilizing the "prudent parent standard," caregivers will use "careful and sensible parental decisions that maintain the child's health, safety and best interests." By utilizing this standard, the caregiver will determine the appropriateness of the activity in consideration of the child's age, maturity and developmental level. *(Section 362.05 of the Welfare & Institution Code)*

Travel

If you expect to travel with a dependent child this summer, you must obtain prior authorization from the child's social worker if the travel is for more than two days. If you are traveling out of Ventura County with a child(ren) that is placed in your care, be sure to inform the assigned social worker of where and when you will be leaving and returning to Ventura County. Please plan to provide dates of travel, location(s) and emergency contact information.

If you are traveling out of California, you will need to be sure to inform the assigned social

worker at least two weeks before the trip begins with travel dates and times, as well as where you and the child(ren) will be staying.

For travel outside of the United States, please provide the assigned social worker with at least 60 day notice in order to obtain court approval for this travel and for the child(ren) to obtain a passport. You will need to provide travel dates/times and location where you and the child(ren) will be staying.

Please remember that travel may impact visitation schedules. The child's social worker may ask you to make arrangements that are outside of the typical visitation schedule before or after the travel takes place.

Alternate Caregivers

If the caregiver (relative or foster) will be absent from the home for 24 hours or less, they are permitted to arrange for an alternative caregiver who will provide care and supervision of the child for occasional, short term care, taking into consideration the age and needs of the child. The caregiver shall apply the "reasonable and prudent parent standard" when identifying a caregiver. If the caregivers will be absent for over 24 hours, the following criteria must be met for these individuals: must be 18 years of age or older, must have completed the criminal record clearance requirement, and be able to comply with statutes and regulations. The care and supervision of the child must occur at the caregiver's home. The caregiver must notify the child/ren's social worker and Licensing Program Analyst of travel dates, name of the alternative caregiver and emergency contact information. If the absence will exceed 72 hours, prior approval from the social worker is required. Contact our Placement Coordinators to help make arrangements for respite coverage.

Children's Services Auxiliary (CSA) Summer Camp Reimbursement

The CSA is pleased to offer camp scholarships for Ventura County's court dependent children to experience the excitement of residential or day camps. Scholarships are not guaranteed and funding is limited, so reserve your space now. Please contact Victoria Camacho at (805) 654-3220 or via e-mail, victoria.camacho@ventura.org, to reserve your scholarship.

Caregivers may select any camp that meets the child's needs! Requests for funding will be processed in the order they are received. All of the required documentation must be submitted at the time of the funding request. Summer Camp funding requests must be submitted no later than August 31, 2014.

- It is the responsibility of the caregiver to select an appropriate camp and to confirm space is available. When you register the child, be sure to ask if there are any scholarships available.
- You may need to pay at a deposit, if not the entire fee at the time of registration. You can be reimbursed up to \$300.
- Make sure you get a receipt that includes the child's name, name and dates of the camp, how much was paid, and if there is a balance due.

Respite Care through Channel Islands Social Services

Did you know that county foster parents are eligible for up to 12 hours of FREE respite care each month? Are you utilizing this great resource to take a break and care for yourself as a foster caregiver? Families caring for children ages 9 and under are automatically eligible and can contact Channel Islands Social Services directly at (805) 384 0983 to register. If you are caring for children over 9, you can contact Suria at 654- 5581 or suria.gottesman@ventura. org for case-by-case approval. If you are caring for a child with special or unique needs, please contact Suria to discuss respite care and a possible approval of additional hours.

Low to No Cost Preschool for Foster Children

The Easter Seals Child Development Center will have openings for children ages 2-5 beginning in August! Foster children typically qualify for very low or no cost services. Preschool schedule is dependent on the family's work or school schedule and will be determined at the time of application. Easter Seals also offers a part time program for children preparing for kindergarten! Apply early to ensure a spot in August! Families will be asked to provide a copy of their placement agreement, as well as verification of the amount of funding you are receiving to care for the child. Orthodontic Grants Available for Dependent Minors

The Children's Services Auxiliary has capacity to apply for 5 Orthodontic Grants through The Change a Life Foundation each year. These grants are reserved for those youth who meet the foundation's criteria, have been denied by Medi-Cal and whose total need does not exceed \$5,000. There are currently only 2 names on this waiting list. If your child is in need of orthodontia, and has been denied by Medi-Cal, please speak to your social worker about requesting grant assistance through the Children's Services Auxiliary. Your case will be promptly reviewed and if all criteria are met, the child's name will be placed on the waiting list. Space is available on a first come first served basis, so please do not delay!

Laptops for Youth in Foster Care

The Children's Services Auxiliary (CSA) has several laptops available for youth ages 11-21 in the foster care system. If your child is in need of a laptop, please contact your child's social worker to submit a request on the child's behalf. The CSA will contact you within 60 days.

Foster Care Snapshot: The Critical Need Continues...

In the month of March 2014:

- A total of 1,238 cases were open with CFS.
- 44 new cases were referred and 21 cases were closed.
- We have 206 active County and Foster Family Agency homes.
- We have 209 Relative Caregiver homes.
- We welcomed 9 new foster homes into the CFS family!!

Please help us spread the word about the need for quality foster homes! Remember, foster parents are eligible to receive an incentive of \$100 for referring a family once they complete the licensing process and an additional \$100 once a child is placed in the new foster family's home!
